PATIENT ASSISTANCE PROGRAMS PROVIDE FINANCIAL ASSISTANCE TO HELP ELIGIBLE PATIENTS ACCESS LIFESAVING THERAPIES AND SERVICES PRESCRIBED BY THEIR PHYSICIANS. IN 2017, NORD PROVIDED FINANCIAL ASSISTANCE TO 7,464 PEOPLE WITH RARE DISORDERS. IN ADDITION, NORD WORKS WITH ORGANIZATIONS CONDUCTING CLINICAL TRIALS OF NEW TREATMENTS IN ARRANGING FOR PATIENTS WITH RARE DISORDERS AND FAMILY MEMBERS TO TRAVEL TO THE SITES WHERE THE TRIALS ARE BEING CONDUCTED. IN 2017, THERE WERE 345 PATIENTS THAT NORD ASSISTED IN TRAVELING TO THESE SITES.

IN 2017, NORD AWARDED FOUR RESEARCH GRANTS TO ASSIST IN THE STUDY OF CERTAIN RARE DISEASES. THE OBJECTIVE OF THE GRANTS AWARDED IS TO PROMOTE BETTER UNDERSTANDING OF RARE DISEASES, EARLIER DIAGNOSIS, AND OPTIMAL TREATMENT FOR PEOPLE WITH THESE DISORDERS. ALSO IN 2017, NORD HAS CONTINUED TO DEVELOP ITS NATURAL HISTORY/REGISTRY PLATFORM TO HELP RESEARCHERS BETTER UNDERSTAND THE PATIENT EXPERIENCE AND PROMOTE DEVELOPMENT OF INNOVATIVE, SAFE AND EFFECTIVE THERAPIES. AS OF DECEMBER 31, 2017, THERE WERE 4,571 PARTICIPANTS ACROSS 16 DISEASE-SPECIFIC DATABASES.

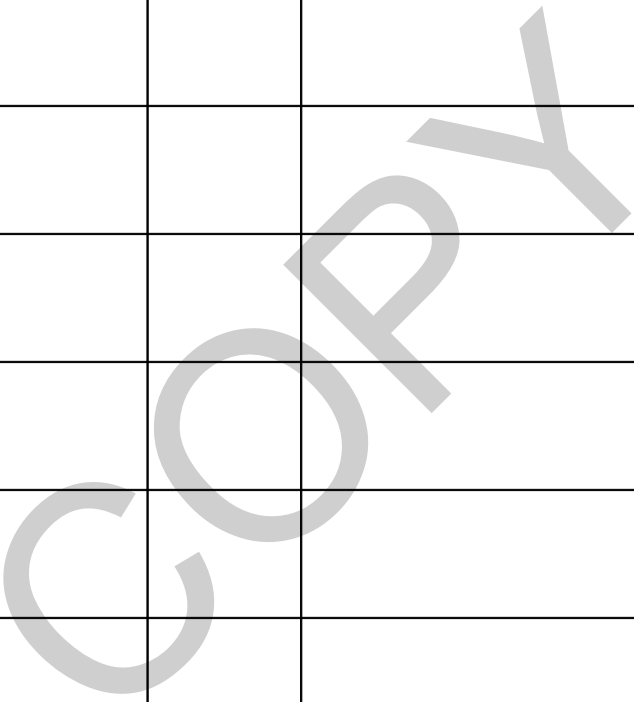

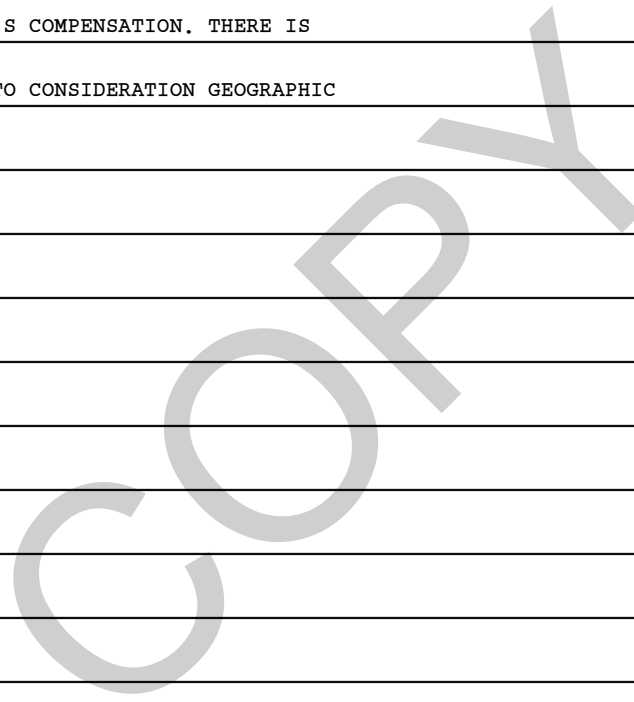
